Ms. Sheri Benson, president, called the meeting of the Heartland AEA Board of Directors to order at 4:32 p.m.

Approval of Agenda

A MOTION was made by Dr. Rose and seconded by Mr. Evans to approve the agenda. The motion passed unanimously.

Work Session

Listening Circles and Other Social, Emotional, Behavioral & Mental Health Supports (SEBMH)

Ms. Nicole Craun, a Heartland AEA Challenging Behavior & Autism Consultant, and Dr. Kristi Upah, Heartland AEA Chief Student Services Officer, discussed the Agency's recent efforts to support SEBMH needs for students and for our staff. They shared information about the training modules that will be released next week for teachers which will help them develop the skills they need to support safe classroom learning environments.

Dr. Upah shared the results of the Agency's Listening Circles, a restorative practice that helps develop relationships and build communities. The Listening Circles were held this fall as a resource to help agency staff around their well-being. The topic focused on the impact of the COVID-19 pandemic, and 60 staff participated.

Association of Educational Service Agencies (AESA) Presentation About AEA Scout

Ms. Sheila King, Heartland AEA Chief Information Officer, and Ms. Susan Schrader, Heartland AEA Director of Resources & Library Services, shared highlights from the AEA Scout presentation that was part of the annual AESA conference. AEA Scout is an online portal that houses digital resources that teachers and students can access through one interface. It's currently being piloted in several school districts across the state and will be further deployed as it continues to be developed.

Equity Choice Board

Dr. Jon Sheldahl, Heartland AEA Chief Administrator, highlighted the new learning opportunities available on the social justice and equity board.

FY 2022 Budget Conversation

Mr. Kurt Subra, Heartland AEA Chief Financial Officer, walked board members through the proposed FY 2021-22 budget. He shared the impact that declining enrollment brought about by the COVID-19 pandemic will have on the Agency's budget. Several supplemental state aid scenarios were reviewed, and he discussed the Agency's solvency ratio which is expected to decrease next year.

Chief Administrator Professional Development Goals

Dr. Sheldahl provided a mid-year update on his professional development goals. He reported that work is taking place in the areas of mental health and well-being and leading the Agency toward becoming a more equitable, socially just and anti-racist organization. Agency leaders will participate in Mental Health Frst Aid training this month, and the organization has contracted with the New York Leadership Academy on equity training.

Chief Administrator's Reports and Recent Activities

- Legislative Update Dr. Sheldahl discussed the upcoming legislative session. The AEAs will advocate for higher supplement state aid, an allocation for mental health services and equitable AEA funding. It's expected that a bill will be presented to address open enrollment desegregation.
- COVID-19: Resolution and Families First COVID-19 Relief Act (FFCRA) Benefits Dr. Sheldahl discussed the pandemic resolution that will allow the Agency to extend FFCRA or similar benefits through June 30, 2021.

Pandemic Resolution

A MOTION was made by Ms. Borgen and seconded by Mr. Kinley to approve the pandemic resolution. Motion passed unanimously.

Dr. Bridgewater reviewed the financial statements and indicated everything was in order.
