## Approval of Agenda

A MOTION was made by Dr. Rose and seconded by Ms. Benson to approve the agenda. The motion passed unanimously.

## Family & Educator Partnership (FEP)

Ms. Kari Paulsen, Heartland AEA Lead Family & Educator Partnership Coordinator, and Ms. Johnna Deaton-Davis, a Heartland AEA Family & Educator Partnership Coordinator, discussed services and supports for schools and families of students served by special education. FEP coordinators are parents of children with special needs, so they share a unique perspective with the families they serve. Services range from transition planning, to providing information about wills, guardianships, waivers and insurance, to attending meetings IEP meetings with families.

# **Chief Administrator's Report and Recent Activities**

Dr. Sheldahl, Heartland AEA Chief Administrator, provided a brief legislative update.

- SSB 3080 Student Vouchers A hearing was held today on the vouchers. At this time it's unknown if there are enough votes for the bill to pass.
- HF727 AEA Reorganization This bill would consolidate the AEAs from nine to four. Once the bill is
  introduced into Appropriations, it's alive throughout the session. There is still uncertainty around the
  sentiment that's behind the reintroduction of the bill.

## **Retention Bonus**

Dr. Sheldahl asked the Board to consider a recommendation that would authorize a retention bonus for regular fulltime and part-time staff employed as of March 8, 2022. The bonus would encourage staff retention and act as encouragement and as a token of appreciation for their work during the ongoing pandemic.

# **Classified Staff 2022-23 Compensation**

Mr. Kurt Subra, Heartland AEA Chief Financial Officer, noted that the negotiations with the Certified Union group settled at a total compensation package increase of 2.75%. It's recommended that a total compensation package increase of 2.75% be given to Classified staff for 2022-23.

## Leaders 2022-23 Compensation

A recommendation was made for a total compensation package increase of 2.63% for the Heartland AEA Leaders group for 2022-23.

## **Board Policies - First Reading**

Board members had a first reading of several updated board policies. The edits were made based on recommendations from the Iowa Association of School Boards, which were reviewed and discussed by the Agency's Board Policy Committee.

## **Action Items**

# **Negotiations - Certified Union/HEA**

A MOTION was made by Ms. Benson and seconded by Dr. Rose to approve the tentative agreement with the Heartland Education Association (HEA) for 2022-23. The motion passed unanimously.

## **Classified Staff 2022-23 Compensation**

A MOTION was made by Dr. Rose and seconded by Ms. Brennan to approve the Classified staff compensation recommendation as specified (2.75% total package increase for 2022-23). The motion passed unanimously.

## Approval of Leaders 2022-23 Compensation

A MOTION was made by Ms. Borgen and seconded by Ms. Brennan to approve the Leaders total package compensation increase (2.75% total package increase for 2022-23). The motion passed unanimously.

## **Retention Bonus**

A MOTION was made by Dr. Rose and seconded by Ms. Benson that in order to encourage the retention of all staff during the ongoing pandemic and in order to reward staff for their ongoing work to provide quality services during the pandemic, Heartland AEA will offer all full-time staff members a \$1,000 bonus and all part-time staff members a \$500 bonus, if employed as of March 8, 2022. The motion was enthusiastically and unanimously passed. The Board noted they were proud to do this for Heartland AEA staff.

## **Consent Agenda**

Ms. Brennan reviewed the financial statements and indicated that all was well. A MOTION was made by Ms. Benson and seconded by Ms. Schwenk to approve the consent agenda including payment of warrant numbers 415426 through 415556 and electronic warrant numbers 36998 through 37401. The motion passed unanimously.
