### **To access the Course Proposal:**

Click on **Instructor Center** in the tabs along the top of the screen. (Contact the PL Team if you do not have the **Instructor Center** tab.) On the **Course Approval Home** page, click the **Propose Course** drop-down icon (☺) located on the right-hand side of the page, and then click on **New Instructor Led Course**.

Please Note: The completed proposal must be submitted at least **three weeks prior to the start date**.

The Course Proposal page will timeout in approximately 60 minutes. Here are some suggestions so you don't lose your work:

- Since this is a web-based proposal, type and save your course information in a Word document and copy/paste into the appropriate fields. (Worksheet available.)
- **OR...**On the Course Proposal, the required fields are identified by an asterisk (\*). Each required field must contain a value before the form can be saved. If you need to save an incomplete form, type any letter into each required field, save the form, then return to enter complete information at a later time.
- **OR...**Enter content in the required fields first, save the form, then continue filling out the optional fields. To save your work while completing the form, click **Save Draft** at the bottom of the page.
  - To access your course saved as a **Draft**, click on **Instructor Center** tab and then click **Course Projects**.
  - From the **Actions** dropdown menu, click on **Edit Course**
  - On the next page you will need to again click on **Edit Course**
  - On the dropdown beside **Manage Instructor Led Course**, click on **Edit**

**Course #:**

Your course number is automatically generated when you click **Save Draft** or **Create Instructor Led Course**. You will be able to search for your course using the assigned **Course #** in your Instructor Center and on the Course Catalog.

### Attendance Policy:

All students must attend all class sessions and activities to receive credit for the class.

### \*Format:

**Face-to-Face:** The learning is led face-to-face with an instructor, occurring over a semester, school-year, or a designated time period. A designated instructor(s) builds, leads and/or supports the course instruction.

**Online:** The learning is done entirely through an online format and *should be proposed through AEA Learning Online*, not Heartland AEA.

**Hybrid/Blended:** The learning is done through a combination of face-to-face instruction and instructor-led facilitation online. Participants learn at least in part through online delivery of content and instruction with some element of control over time, place, path, and/or pace, and, at least in part, at a supervised designated location.

**\*Type:**

**Course:** This is a structured learning opportunity that has an instructor/presenter and meets the requirements for credit.

**Learning Team:** This learning opportunity is tailored to meet district and/or content specific audience's needs and meets the requirements for credit. The learning team concept presents a way for educators to work in cooperative groups to identify issues and goals, research professional literature, implement new learning, share experiences and ideas, and problem-solve real situations.

**Meeting:** Gathering or coming together of stakeholders from different areas to improve knowledge. This could be a couple of hours or half day. Credit is not available for meetings.

**Workshop:** A learning opportunity that does not meet the requirements for credit.

**Open Audience:** Select if your course is available to anyone to register.

The License Renewal program at Heartland AEA operates on a pass-fail basis. A passing grade would be the equivalent of an "A" or "B" grade in a graduate course. If the course carries graduate credit, a letter grade of A, B, C, D or F must be assessed. **The criterion used is the same for both graduate credit and license renewal credit.**

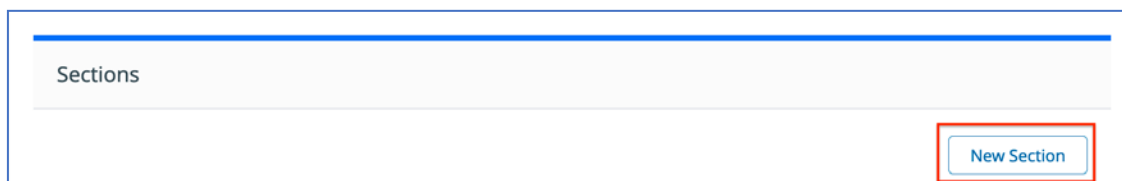

## Add a Section

Once you have clicked **Create Instructor Led Course**, scroll down to **Sections** and click on **New Section**.

**Note:** A section cannot be added to a course saved as draft.

### Location/Room Number:

Select **No**. Heartland AEA does not have waiting lists on any activities.

Select the first meeting date for this section. (This will determine the default first date when defining specific class times.)

**\*Section End Date:**

Select the date you want the coursework to be due. This will be considered the end date of the course. (This will determine the default end date when defining specific class times.)

**End of Registration Date:**

Enter a date if you have a deadline for registering for this section. (Not required)

**Waitlist cutoff Date:**

Not required. Heartland AEA does not have waiting lists on any activities.

Once the form is complete, click **Create** to create the new section.

---

**Manage Instructors: (Instructors)**

This role is responsible for facilitating a section within the system. (This may or may not be the person actually teaching the section.) Functions include managing the roster, taking attendance, issuing credit, and managing communications. The PL Team will be able to manage this section.

Assign Course Instructor(s) following these steps:

1. Click **Instructors**
2. Search for the user by first or last name. Then click **Find User**.
3. Select the checkbox for the desired user, then click **Add User(s)**.
4. Selected users will be listed.
  - To remove multiple users at once, select the checkboxes next to their names, then click **Remove Selected**.
  - To remove a specific user, click the applicable trash can icon.
5. When finished managing **Instructors**, click **Done**.

The **Instructor's name** and **email address** appear on the Catalog. (This is the same email address that the instructor uses to log into the AEA Learning System.)

**Manage Class Times: (Class Times)**

Set the specific meeting days and times for your section.

1. Click **Class Times**.
2. Click **Add New Day**.
3. The date and times will default to the Start Date, Start Time and End Time you entered on the section form. Adjust as needed.
4. Continue to add days and adjust as necessary. **Only include dates and times you are actually meeting**.
5. The class schedule will be displayed.
  - To remove all class times at once, click **Remove All**.
  - To remove a specific class time, click **Remove**.
  - To save your class times and keep working, click **Save**.
6. When finished setting class times, click **Save & Exit**.

**Manage Roster: (View Roster)**

This function will be used once the course is active to manage the section roster. The button will be disabled until the course/section has been approved.

**Manage Sections Fees: (Sections Fees)**

Fees can be applied to a section in addition to any course fees. These fees can be required or optional. Please contact the PL Team.

### Course: (Manage Course)

If you want to add another section, click **Manage Course** to return to the Manage Course screen. Repeat these steps until all sections have been added.

### Manage Room Requests: (Manage Rooms)

We are not using this feature.

Contact the PL Team to make a room request. If you are a Heartland employee, please use **Heartland AEA Event Scheduler System**.

## Submit for Review

### To submit your course for Review:

1. When satisfied with all information for your course, click **Submit for Review**.
2. Click **OK** when the pop-up appears.
3. Click **OK** again to close the confirmation.

Your course will no longer appear in **Course Projects**; it will now appear in **Submitted Courses**. The course cannot be edited while in review; you can only view or copy it.

After your course has been reviewed, you will receive an email indicating whether your course has been approved or denied (returned for additional information or revision).

### Denied Course:

If your course has been returned for additional information or revision, you will find your course by selecting your **Instructor Center** tab and then go to **Denied Courses**. The notes will indicate the specific information that needs to be revised before the course is resubmitted for approval. Contact the PL Team if you have questions.

### Approved Course:

After your course is approved, you will find your course by selecting your **Instructor Center** tab and then go to **Approved Courses**. You will also be able to access the courses you are teaching under the **Courses I'm Teaching** channel on your **Home** tab.

## Adding a New Section to an Approved Course

Click on **Instructor Center** in the tabs along the top of the screen  
Click on **Approved Courses** on the left  
Click on the arrow to the left of the course title  
Choose **Manage Course** (you won't be able to make any changes to the course information)  
Scroll to the bottom  
Click on **New Section** over to the right  
Complete the information (following the directions on pages 8-11 above)  
Click on **Request Approval** to submit it
