Informed Consent Conflict Waiver Agreement for Shared Services with Perry CSD

When two entities use the same law firm, the law firm needs to acknowledge there could be a conflict of interest. If a conflict arises, Ahlers Cooney would not be able to represent either Heartland AEA or the district.

Mr. Subra discussed allowing other HRA eligibility options given the uncertainty of the current legislative session. If there is a separation of employment over the next 17 months, staff would be able to access HRA funds if they meet the requirements.
