BOARD MEETING

Ms. Margaret Borgen, board president, called the meeting of the Heartland AEA Board of Directors to order at 5:01 p.m.

Approval of Agenda

A MOTION was made by Ms. Brennan and seconded by Mr. Evans to approve the agenda. The motion passed unanimously.

Discussion Items

Legislative Update

Dr. Cindy Yelick, Heartland AEA chief administrator, shared that the AEA Bill passed the Senate today and will be signed by the Governor tomorrow. She shared the impact on the special education, educational services and media services budgets. A portion of the bill also reconfigures the makeup of the board, now requiring five superintendents or designees. Dr. Yelick will be a participant on the special Task Force that will present a final report by the end of the year. Board members shared their sadness and great disappointment in the passing of the bill and thanked her for all of her advocacy efforts. They discussed concerns regarding the impact of the bill on lowa students, teachers and AEA staff.

Classified Staff 2024-25 Compensation

Mr. Fangman, Heartland AEA Chief Human Resources Officer recommended a 3.5% salary and wage increase for classified staff for 2024-25. The recommendation also includes six staff who will receive slightly higher increases (not to exceed 5%) based on hiring agreements.
